DIRECTLINE Timbers Privacy Policy

Your privacy is critically important to us. At DIRECTLINE Timbers we have a few fundamental principles:

- We don't ask you for personal information unless we truly need it. (We can't stand services that ask you for things like your gender or income level for no apparent reason.)
- We don't share your personal information with anyone except to comply with the law, develop our products, or protect our rights.
- We don't store personal information on our servers unless required for the on-going operation of one of our services.

Website Visitors

Like most website operators, DIRECTLINE Timbers collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. DIRECTLINE Timbers's purpose in collecting non-personally identifying information is to better understand how DIRECTLINE Timbers's visitors use its website. From time to time, DIRECTLINE Timber may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Gathering of Personally-Identifying Information

Certain visitors to DIRECTLINE Timbers's websites choose to interact with DIRECTLINE Timbers in ways that require DIRECTLINE Timbers to gather personally-identifying information. DIRECTLINE Timbers does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

Aggregated Statistics

DIRECTLINE Timbers may collect statistics about the behavior of visitors to its websites. DIRECTLINE Timbers may display this information publicly or provide it to others. However, DIRECTLINE Timbers does not disclose personally-identifying information other than as described below.

Protection of Certain Personally-Identifying Information

DIRECTLINE Timbers discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on DIRECTLINE Timbers's behalf or to provide services available at DIRECTLINE Timbers's websites, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using DIRECTLINE Timbers's websites, you consent to the transfer of such information to them. DIRECTLINE Timbers will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, DIRECTLINE Timbers discloses potentially personally-identifying and personally-identifying information only in response to a subpoena, court order or other governmental request, or when DIRECTLINE Timbers believes in good faith that disclosure is reasonably necessary to protect the property or rights of DIRECTLINE Timbers, third parties or the public at large. If you are a registered user of an DIRECTLINE Timbers website and have supplied your email address, DIRECTLINE Timbers may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with DIRECTLINE Timbers and our products. We primarily use our various product blogs to communicate this type of information, so we expect to keep this type of email to a minimum. If you send us a request (for example via a support email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. DIRECTLINE Timbers takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

Cookies

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. DIRECTLINE Timbers uses cookies to help DIRECTLINE Timbers identify and track visitors, their usage of DIRECTLINE Timbers website, and their website access preferences.

DIRECTLINE Timbers visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using DIRECTLINE Timbers's websites, with the drawback that certain features of DIRECTLINE Timbers's websites may not function properly without the aid of cookies.

Business Transfers

If DIRECTLINE Timbers, or substantially all of its assets, were acquired, or in the unlikely event that DIRECTLINE Timbers goes out of business or enters bankruptcy, user information would be one of the assets that is transferred or acquired by a third party. You acknowledge that such transfers may occur, and that any acquirer of DIRECTLINE Timbers may continue to use your personal information as set forth in this policy.

Ads

Ads appearing on any of our websites may be delivered to users by advertising partners, who may set cookies. These cookies allow the ad server to recognize your computer each time they send you an online advertisement to compile information about you or others who use your computer. This information allows ad networks to, among other things, deliver targeted advertisements that they believe will be of most interest to you. This Privacy Policy covers the use of cookies by DIRECTLINE Timbers and does not cover the use of cookies by any advertisers.
